

About “PAD”: The Pre-Authorised Debit Program

The PAD Program is a service offered by MAMRT which allows for Full-Practising members to pre-pay - one year in advance - CAMRT and MAMRT Dues, Fees, and Professional Liability Insurance (PLI) premiums. For example, a PAD subscriber begins to pay towards 2019 in the year 2018.

Pre-payment is made through monthly bank account debits, over 11 months, January to November, based upon the expected total. If any increases or decreases to the total amount were to occur, the monthly debit calculations are adjusted accordingly over the months of August, September, October, and November.

Existing subscribers to the PAD Service are required to renew their Agreement on an annual basis and do so in the PAD renewal month of October. Revocation/cancellation may be made at any time, with 30 days prior written notice to the MAMRT office, and a full refund will issue.

New subscribers to the PAD Service will be required to complete an Agreement (see sample below) and to provide a copy of a “void” cheque. To subscribe, contact: admin@mamrt.ca

Sample 2018 PAD AGREEMENT:

PRE-AUTHORIZED DEBIT (“PAD”) AGREEMENT AND AUTHORIZATION - I hereby authorize the **Manitoba Association of Medical Radiation Technologists Incorporated** (hereinafter MAMRT) to debit my bank account (hereinafter PAD Account) on a monthly basis (January to November) with the intent to pay the annual membership dues, fees and other charges of MAMRT and of the **Canadian Association of Medical Radiation Technologists** (hereinafter CAMRT) one year **IN ADVANCE**.

I further authorize MAMRT to increase or decrease the monthly amount debited from my PAD Account during the months of August to November of each year to address any changes in annual membership dues, fees or other charges as may be declared by MAMRT or CAMRT from time to time. As the amount that may be required to address any such changes is variable, I waive any requirement for pre-notification.

I undertake to renew my subscription to this service annually, until such time as I cancel this PAD Agreement. I understand that I may cancel this PAD Agreement at any time, by giving MAMRT 30 days prior written notice. I further understand I may contact my financial institution or visit www.cndpay.ca for more information on my rights to cancel this PAD Agreement.

I agree to notify MAMRT in writing of any change in my PAD Account information at least 30 days prior to the next due date of a PAD. I further understand that failure to maintain sufficient funds in my PAD Account or failure to advise MAMRT of any change to my PAD Account will result in additional administrative charges and cancellation of this PAD Agreement.

I am aware that I have certain recourse rights if any PAD does not comply with this Agreement. For example, I have the right to receive reimbursement for any PAD that is not authorized or is not consistent with this PAD Agreement. IMPORTANT:

1. The PAD Program is a service available only to Full-Practising Members.
2. An additional annual \$25.00 PAD administrative fee is applied upon subscription.
3. 30 days notice - in writing - is required for cancellation/revocation.
4. 30 days notice - in writing and prior to the next debit due date - is required to effect any bank account changes.
5. Failure to maintain sufficient funds or to provide the notice as set out in #4 above will result in automatic cancellation of the service and an additional \$40.00 fee charged.
